WE ARE AT PHASE 2!

What's that, I hear you ask? Last week, our church council voted in a set of guidelines and "Phases" to reopen OCUMC's building and ministries. Phase 1 is where we were at for months - pretty much shut down. Phase 5 will be when everything is back to normal.

Here are a few highlights of Phase 2

- We can now have groups of up to 10 in a room.
- o Still in face-masks. Still social distancing.
- o Ministry groups still meet online/outside.
- o Entrance through the main front doors, exit through the side doors.
- o Bathrooms/stalls are cleaned after ONE use (please "go" before you go to church)

It might not seem like that big of step, but at least we can have a few committee meetings in the building. Phase 3 is when we really get a big step forward with a limited worship service, up to 50 people in the building, etc. You can read below our Phases and criteria for each.

To move to a new Phase, we need to be able to follow Clackamas County guidelines/Governor's orders; The Bishop's directives, and the District Superintendent's approval.

I know these Phases seem painfully slow. And other churches are opening up. Just know we are going slow, to keep all of you and us, safe. Oregon, our numbers are still going up. And we've made headlines in the national news because of outbreaks.

May we continue to hold each other in prayer, and may we be able to visit each other soon!



Each phase is dependent upon

- 1) Governmental authority guidelines (group #, distancing, etc); Please Note that the County's Phases do not translate exactly into our Phase numbers.
- 2) Bishop's approval. Bishop opened up Phase 2 on June 16th with fear and trepidation...
- 3) DS approval for our proposed guidelines to move to another phase. We have not submitted any plans yet.

There is no prescribed time-frame to move from one phase to the next.

Note: This sheet has general information. Many of the rows have their own tables/sheets with more specific information.

Before the transition to each new phase, and expectations thereof, will be shared through our newsletter, Facebook page, email, and snail mail to our congregation and stakeholders. If we cannot abide by these "Do No Harm" guidelines for each phase, we show that we are not ready for that Phase. They are in place for the safety of all - parishioners, guests, staff, etc. It may come to pass, either by our own actions or more probable, a resurgence of the virus, will cause us to backtrack a phase. Communication of a backtrack phase will be shared by aforementioned means. Signage in church will show hygiene practices, policies, bathroom usage, entrances/exits, and other relevant CDC guidelines.

Notes:

Those taping online worships will wear face masks, except the speaker. Face masks will be required of everyone in Phase 3 when we begin in-person worship. We will have a couple dozen to hand out. We will wash them each week. If someone doesn't wear a mask during the required times, we can't have church for a week (DS rule - if we get out of church at 11 a.m., the next service can't start till 11 a.m. the following week). Pastor and Head Usher will enforce.

All doors to unnecessary rooms will be locked - including office, until needed.

Live singing and wind/brass instruments: Singing and projecting instruments spray droplets in the air. Sadly, none of these musical modes are welcome until Phase 5. Careful recording in Sanctuary may begin in Phase 2.

Number of worships: For Phase 3, we anticipate two worships that can have max 50 in TOTAL attendance. We will take "reservations" up to 40, allowing a few visitor spots. Should we reach over-capacity in our space, we will have designated people who love Jesus enough to give their spot to a guest or unregistered individual. Another side room could be available to stream the service. Worst case, some people will be nominated to leave - I pick Steve.

Communion will be "hands free" in Phase 4. No Communion allowed for Phases 1-3. (Even drive up)

Chairs: Chairs will be a one-use per week for phases 3-4. Used ones will be stacked along south wall and wiped down in the week. The next worship will use new chairs.

Children/youth will need to stay with family groups in phases 3-4; No running around. No up-front kids time...

Attendance for Contract Tracing will be a written log.

When we go to online AND live worship, the online version should switch to a live stream model. Taping ahead of time is a lot of work!

Sanitation: Our custodian (or other volunteer) should be on hand for wiping down surfaces, chairs, and bathrooms. Water fountains are closed. The custodian will be in charge of sanitation supply inventory.

Bathrooms: 1 person in the bathroom at a time. 1 use per stall per cleaning. We have a way to notify others that the stall is unclean. We prefer if people would go at home. "Go before you Go" could be a catchphrase!

Entrance will be through the front doors, and exit will be through the south doors and out in Phases 1-4.

Offering: While one can always give online or mail a check, we will have an offering box for Phases 3-4 and not pass a plate. We will, however, have an usher bring a plate forward at offering time.

High Risk Populations: The CDC gives examples such as persons ages 65+, those in care facilities and those who have underlying medical conditions. It will be up to each individual to police themselves - we will not stop anyone from coming to worship.

People may light a candle in our memorial votives, there will be a container for used bamboo sticks

Parents of children will have to monitor their own children. We will not be passing out activity bags due to sanitation reasons - feel free to bring your own (no noise makers, be considerate of others). The nursery is not available.

Microphones will be wiped down and sanitized at the end of use, and between sharing of a mic if nec.

Folks entering and leaving the worship space in Phases 3-4 cannot stop and chat with other groups of people or clutter up hallways/doorways. Take the chat with other family groups outside. Phases 3-4. Painful, I know...

* Beginning in Phase 2, Recording a singer is limited to 1 soloist a week and no one else present at the time of singing – tech, etc. if not from same household needs to vacate room likewise no additional person to accompany unless from same household.

Celebration Sunday/Prayer Cards: In Phases 3-4, people may email or text their joys/concerns before the service OR at the appropriate time in the service. They may also share from their seat. Text number up on the slide.

It goes without saying that the choir is on hiatus right now. If we start a bell choir, max group size, physical distancing and sanitizing required as needed in the phases.

Building Use is majorly restricted by the Conference until Phase 4. Before that, it is limited to staff, volunteers & designated services (essential). Please note the maximum number of people allowed in the building in each stage.

Limited Kitchen use generally means "Coffee Cart".

The Preschool may have the most stringent rules - the county/state are still coming out with procedures and policies. Our preschool will also follow Bishop's building use guidelines.

Women's group, men's group, children/youth group, church clubs and activities are generally prohibited in doors until Phase 4.

Attendance for Contract Tracing will be a written log.

We will revise building use agreements and contracts to reflect new requirements such as face masks, hygiene, physical distancing, cleaning and other Covid-19 realities.

In-person Committee/Church meetings can begin again in Phase 2, limited to 10 people in masks.

The Sanctuary will be used to help social distancing. People can still ZOOM into meetings.

Face masks will be required of everyone through Phase 3 if within 6 feet of each other. Optional after that. We will have masks on hand, if nec. If someone doesn't wear a mask during the required times, the space is shut down for a week. Pastor and Committee Chair will enforce.

All doors to unnecessary rooms will be locked including office, until needed.

Chairs: Chairs will be a one-use per week for phases 1-4. Used ones will be stacked along south wall and wiped down in the week. The next meeting will use new chairs.

We will take written attendance for Tracing.

Sanitation: Tables will be wiped down before and after meetings. Pastor and/or Committee Chair will make this happen. Water fountains are closed. Bathrooms: 1 person in the bathroom at a time. 1 use per stall per cleaning. We have a way to notify others that the stall is unclean. We prefer if people would go at home. "Go before you Go" could be a

catchphrase! The custodian will be in charge of sanitation supply inventory.

Entrance will be through the front doors, and exit will be through side doors in Phases 1-4.

High Risk Populations: The CDC gives examples such as persons ages 65+, those in care facilities and those who have underlying medical conditions. It will be up to each individual to police themselves - we will not stop anyone from coming to worship.

Folks entering and leaving the worship space in Phases 1-4 cannot stop and chat with other groups of people or clutter up hallways/doorways. Take the chat with other family groups outside. Painful, I know...

Handouts - we ask that handouts be electronic, if possible. The passing of sheets around the table cannot happen until Phase 5. We ask the Committee Chair or Pastor to hand out paper, if necessary, with gloved hands.
